Prize

- One winner will be randomly selected via Shortstack social media campaign system at 7:30pm on Thursday, August 18, 2022, and win (2) digital tickets to Live Nation produced and promoted concert at Fed Ex Forum through the Hollywood Casino Tunica Instagram page for the September 9, 2022, concert.

Eligibility:

- Must be a member of the **mychoice** patron loyalty program.
- Must be 21 years of age or older to obtain a **mychoice** card.
- No purchase necessary to receive a **mychoice** card.
- A government issued photo ID is required to verify age and identity.
- Must have the *mychoice Rewards* loyalty app downloaded and registered to a mobile device
- This promotion is valid only at Hollywood Casino Tunica and nontransferable.
- Patrons must follow us on Instagram at Hollywood Casino Tunica, comment on August 15, 2022, giveaway post, and tag two friends to complete one entry.
