BANQUET POLICIES



GUARANTEE

Menu prices are guaranteed 90 days prior to the event and may be subject to change without notice. Guaranteed number of attendees is due 12 business days prior to the function along with full payment. Event held on Saturday, Sunday or Monday must be received by 11:00am the preceding Tuesday.

PAYMENT

Full payment is due 12 business days prior to event unless credit has been established. A credit application, if requested, must be received by the hotel's accounting department one month prior to the event. If credit has been established, full payment is due within 30 days of the event date. An advance deposit will be required. Prices quoted do not include 10% Mississippi state sales tax or 21% gratuity. Prices are subject to change without notice, and will not be guaranteed more than 90 days prior to any event date.

AUDIO VISUAL

A wide variety of audio visual equipment rentals and services are available. Please place your order at least one week in advance through the Catering Department.

FOOD AND BEVERAGE

No food or beverage of any kind will be permitted to be brought into the meeting or banquet rooms. We consider it our responsibility to enforce the legal drinking age laws of the state. The Banquet Department has the right to charge for the service if such food or beverages are brought into the banquet rooms in violation of this policy.

BANQUET ROOMS

Event space is assigned by the guaranteed minimum number of guests anticipated. Our room rental fees are based upon factors pertaining to your group's function and revenue projections. Revisions in group programs, counts, times, dates, etc. may necessitate a revision of room rental fees and/or room assignments. Additional charges may apply if room times extend outside of contract agreements.

SECURITY/DAMAGE

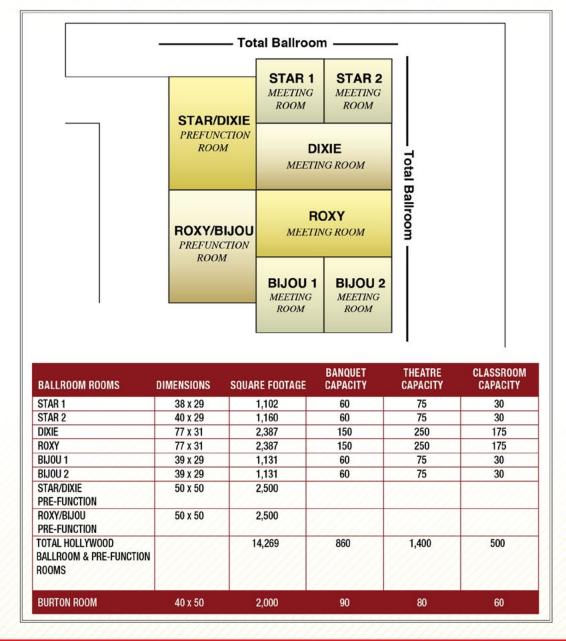
The hotel cannot be responsible for any damage or loss to any article left in the Banquet Rooms or storage areas. All outside security guards provided by the guest will be subject to prior approval of Hollywood Casino Tunica and must show proof of possession and liability insurance. With a 3-week notice, Hollywood may provide security at an hourly rate (4-hour minimum).

SHIPPING AND RECEIVING

Packages for meetings may be delivered to Hollywood Casino Tunica, 1150 Casino Strip Resorts Blvd., Tunica Resorts, MS 38664 no earlier than THREE business days prior to the event. The following information must be included on all packages: GROUP NAME, CONTACT NAME, DATE OF FUNCTION and attention to the Banquet Department. Any alternate arrangements are to be approved by the Catering Department. Guests are responsible for return of any packages. A \$150 storage fee per day will be applied on large shipments or if packages arrive prior to three days in advance of the event.
